Introduction

NRCC conducts an annual survey of its most recent graduates to gather information to help strengthen instruction and services at the college. These data also support planning initiatives for future needs of students, the college, and the community. The Graduate Follow-Up Survey seeks information relevant to satisfaction with experiences at NRCC, perceived preparation at NRCC, and post-NRCC employment and/or transfer to a senior institution.

Methodology

A total of 542 surveys were mailed to New River Community College graduates from Summer 2009, Fall 2009, and Spring 2010. This report does not include practical nursing or associate degree nursing graduates.

Each graduate was initially contacted by mail the second week of July 2011 at the most recent address noted on college records, and asked to complete a survey requesting data relevant to satisfaction with experiences at NRCC, perceived preparation at NRCC, and post-NRCC employment and/or transfer to a senior institution. The graduate was informed that responses would be confidential, and reported in aggregate numbers. For those who failed to respond to the first mailing, a duplicate survey was mailed to the last known address (or a corrected address if available) approximately three weeks later.

Of the 542 graduates contacted to complete the survey a total of 84 valid responses were received from graduates that were subsequently analyzed (a response rate of 15.5%). An additional 31 mailings were returned as undeliverable with no forwarding address (5.7%). The response rate among those surveys that were deliverable was 16.4% (about 7 percentage points lower than the previous survey).

Report Notes:

- Following the tabulation of results are additional sections containing comments from respondents that were written on the surveys and a copy of the survey instrument.
- Each section is labeled in the footer at the bottom of the page to identify the set of respondents the results refer to (as well as comments and the survey instrument).

Results

Survey results are presented in three general categories: all graduates, graduates with transfer awards, and graduates with occupational/technical awards. Because of differential response rates for various survey items, the total number of valid responses for any given item may differ. In addition, total percentages may not add up to 100% due to rounding error.

ALL GRADUATES

These data represent responses from all respondents. Of the respondents to the survey, 28 (33.7%) received AA&S (transfer) degrees, 35 (42.2%) received AAS degrees, and 20 (24.1%) received a Certificate.

The following table shows the employment and educational status of graduates. 'Misc. Enrolled.' includes respondents who reported they were 'Attending some other type of school.' Overall, 49.4% reported working full time, 22.9% part time; 37.3% reported attending school full time, 9.6% reported attending school part time and 50.6% reported they were not enrolled in school. Of those working part time, 73.7% reported continuing their education full time. Of those not working, 57.9% reported continuing their education full time.
