# FINANCIAL AID INFORMATION

If your attendance at New River Community College (NRCC) depends on the financial aid available to you, we strongly recommend that you file the Free Application for Federal Student Aid (FAFSA) as soon as possible. The fastest option for filing the FAFSA is to apply online at <http://www.fafsa.gov>.

**The Title IV School Code for NRCC is 005223.** You must be admitted to NRCC and accepted in an approved curriculum by the Admissions Office before financial aid, which may include grants and loans, can be processed. *Students attending two schools in the same enrollment period must inform both financial aid offices. Students cannot receive grants/loans at two schools in the same term.*

### STEPS TO APPLY FOR FINANCIAL AID AT NRCC

1. Free Application for Federal Student Aid (FAFSA) 2018-2019 complete online at [www.fafsa.gov](http://www.fafsa.gov)
2. NRCC Financial Aid Form – SUMMER ONLY - (<https://www.nr.edu/fa/summer/>)

If you are interested in applying for a *Direct Stafford Student Loan*, you must also complete the following steps:

3. [NRCC Student Loan Request](https://www.nr.edu/fa/loan/) – complete online at <https://www.nr.edu/fa/loan/>
4. [Master Promissory Note \(MPN\)](http://www.studentloans.gov) – complete online at [www.studentloans.gov](http://www.studentloans.gov) - required for first-time borrowers at NRCC (expires after 10 years)
5. [Entrance Counseling Form](http://www.studentloans.gov) – complete online at [www.studentloans.gov](http://www.studentloans.gov) - required for first-time borrowers at NRCC

You may be asked to provide further documentation (i.e., federal tax return transcripts from the IRS, W-2s, etc.) if your FAFSA is selected for verification. We will contact you via your student email. We encourage you to take advantage of the IRS Data Retrieval Tool when completing your FAFSA. Importing data directly from the IRS saves time and reduces the likelihood of being selected for verification.

After your financial aid file is complete, we will evaluate your eligibility for aid and post that information to the Student Information System (SIS). You will also receive an email to your NRCC account directing you to the SIS so that you may view your award (see next page for instructions).

## Student Information System (SIS)

### STEPS TO REVIEW:

Enter your username and password

Click on VCCS SIS: Student Information System to [check account](#) OR [Gmail to check email](#)

Click on Self-Service

Click on Student Center

Click on Account Inquiry – If taking less than 12 credits, choose award year 2019 and click “Update Pending Financial Aid”

You can also view your “To-Do List,” “Pending Financial Aid” and “Outstanding Charges.”

After your award has been made, your student account will be electronically credited with financial aid/loan funds. Typically this is 4 to 6 weeks after the last date to drop and receive a refund. Any remaining balance will be sent to you from Tuition Management Systems (TMS) via the method of your choice. You may update your address online through the Student Information System (SIS) link on our website [www.nr.edu](http://www.nr.edu), or in NRCC’s Admissions Office.

### Application Deadlines

**Application priority dates: Summer-March 15, Fall-April 15, and Spring-November 15.** Applications received by the priority date will receive primary consideration for the upcoming academic year. Those received after the priority date will receive consideration only as funds are available. This application is valid for the 2018-2019 academic year only. Students must apply annually for financial aid.
