I. <u>Course Description</u>

Presents algebra through unit conversion, trigonometry, vectors, analytic geometry, and complex numbers. Prerequisites: A placement recommendation for MTH 131 and developmental math units MTE 1-6. Lecture 3 hours per week.

Prerequisites: Competency in Math Essentials MTE 1-5 as demonstrated through the placement and diagnostic tests, or by satisfactorily completing the required MTE units or equivalent.

II. <u>Introduction</u>

This is a technical mathematics course that includes topics needed in a variety of technical fields. Topics included are algebra, trigonometry, vectors, and complex numbers. A strong background in algebra is necessary for success in this course.

III. <u>Student Learning Outcomes</u>

Upon successful completion of this course, the student will be able to:

- 1. Use a scientific calculator
- 2. Round-off numbers correctly
- 3. Identify significant digits
- 4. Use scientific notation
- 5. Understand/use line and angle relationships
- 6. Understand/use terms related to an angle(s)
- 7. Classify triangles by their sides/angles.
- 8. Calculate the perimeter of a polygon
- 9. Calculate the circumference of a circle
- 10. Calculate the area of a polygon
- 11. Calculate the area of a circle
- 12. Apply concepts of sector and arc length of a circle
- 13. Recognize various geometric solids such as cylinder, cone, pyramid, prism, sphere
- 14. Calculate surface area and volume of various geometric solids
- 15. Understand/use the concept of similar triangles
- 16. Know/apply the radian as a measure of an angle, convert between degrees and radians.

- 17. Define the trigonometric functions and their values
- 18. Solve right triangles and their applications
- 19. Understand the signs of the trigonometric function of angles greater than 90°
- 20. Determine trigonometric functions of any angle
- 21. Solve problems using radian measure and its applications
- 22. Understand vectors and their components
- 23. Solve applications involving vectors
- 24. Understand complex numbers and their basic operations
- 25. Convert between forms of rectangular, and polar complex numbers

IV. Instructional Methods

The instructional procedures will include lectures, discussion, reviews, home work and in-class tests. Students are encouraged to ask questions and respond to questions asked by either the instructor or another student.

VII. Evaluation

The grade for the course will be calculated from Tests, homework, a final exam and other work as deemed appropriate by the instructor. See individual syllabus for details on percentages/points.

VIII. <u>Attendance</u>

Regular attendance at classes is required. When absence from a class becomes necessary, it is the responsibility of the student to inform the instructor prior to the absence whenever possible. The student is responsible for the subsequent completion of all study missed during an absence. Any instruction missed and not subsequently completed will necessarily affect the grade of the student regardless of the reason for the absence.

IX. <u>Cheating Policy</u>

The giving or receiving of any help from another student or unauthorized individual on any graded portion of the course is considered cheating and will not be tolerated. The use of books, notes, electronic devices of any other unauthorized material during tests is considered cheating, and will not be tolerated. Any student found cheating will receive a grade of "0" on that assignment and may receive an "F" for the course. This "0" cannot be replaced by any other score. Mobile phones are not permitted to be used as calculators.

X. <u>Withdrawal Policy</u>

Student Initiated Withdrawal Policy

A student may drop or withdraw from a class without academic penalty during the first 60 percent of a session. For purposes of enrollment reporting, the following procedures apply:

- a. If a student withdraws from a class prior to the termination of the add/drop period for the session, the student will be removed from the class roll and no grade will be awarded.
- b. After the add/drop period, but prior to completion of 60 percent of a session, a student who withdraws from a class will be assigned a grade of "W." A grade of "W" implies that the student was making satisfactory progress in the class at the time of withdrawal, that the withdrawal was officially made before the deadline published in the college calendar, or that the student was administratively transferred to a different program.
- c. After that time, if a student withdraws from a class, a grade of "F" or "U" will be assigned. Exceptions to this policy may be made under documented mitigating circumstances if the student was passing the course at the last date of attendance.

A retroactive grade of "W" may be awarded only if the student would have been eligible under the previously stated policy to receive a "W" on the last date of class attendance. The last date of attendance for a distance education course will be the last date that work was submitted.

Late withdrawal appeals will be reviewed and a decision made by the Director of Student Services.

No-Show Policy

A student must either attend face-to-face courses or demonstrate participation in distance learning courses by the last date to drop for a refund. A student who does not meet this deadline will be reported to the Admissions and Records Office and will be withdrawn as a no-show student. No refund will be applicable, and the student will not be allowed to attend/participate in the class or submit assignments. Failure to attend or participate in a course will adversely impact a student's financial aid award.

Instructor Initiated Withdrawal

A student who adds a class or registers after the first day of class is counted absent from all class meetings missed. Each instructor is responsible for keeping a record of student attendance (face-to-face classes) or performance/participation (DE classes) in each class throughout the semester.

When a student's absences equal twice the number of weekly meetings of a class (equivalent amount of time for summer session), the student may be dropped for unsatisfactory attendance in the class by the instructor.

Since attendance is not a valid measurement for Distance Education (DE) courses, a student may be withdrawn due to non-performance. A student should refer to his/her DE course plan for the instructor's policy.

In accordance with the No-Show Policy, a student who has not attended class or requested/accessed distance learning materials by the last day to drop the class and receive a refund must be withdrawn by the instructor during the following week. No refund will be applicable.

When an instructor withdraws a student for unsatisfactory attendance (face-to-face class) or non-performance (DE class), the last date of attendance/participation will be documented. Withdrawal must be completed within five days of a student's meeting the withdrawal criteria. A grade of "W" will be recorded during the first sixty percent (60%) period of a course. A student withdrawn after the sixty percent (60%) period will receive a grade of "F" or "U" except under documented mitigating circumstances when a letter of appeal has been submitted by the student. A copy of this documentation must be placed in the student's academic file.

The student will be notified of the withdrawal by the Admissions and Records Office. An appeal of reinstatement into the class may be approved only by the instructor.
